## POLICIES AND PROCEDURES

### TERMS OF SALE

Payment must be received prior to shipment or delivery, unless credit has been established. Payment may be made by check, money order or credit card. We accept Visa, MasterCard, Discover and American Express. All C.O.D. charges are the responsibility of the purchaser. An additional \$35.00 fee will be added for returned checks.

### CREDIT

All credit accounts must have a completed credit application on file. Standard terms for open accounts are net 30 days from the date of invoice. Accounts with established credit may buy on open terms provided that no invoices are over 30 days past due. Accounts that are past due incur a finance charge of 1.5% per month (18% per annum).

### RETURNS

Clifton Seed Company will not accept the return of any seeds without proper authorization. With authorization, we will accept returns for full credit (less applicable shipping charges) on unopened items returned in good condition within 7 days of purchase. Special order items that we do not normally carry in stock are not returnable

### ORDERING

Orders are accepted via U.S. mail, telephone, fax, website or e-mail. If you order by mail, please be certain to include your telephone number or email address in the event we need to contact you concerning your order. Orders received by 5:00 p.m. will ship the following day whenever possible. Office hours are from 8:00 a.m. until 5:00 p.m. Monday thru Friday.

### SPECIAL ORDERS AND BACKORDERS

Special orders and items that are temporarily out of stock will be shipped at the earliest possible date. While we are happy to locate and special order items for our customers, items not normally carried in our stock are not returnable, and become the responsibility of the purchaser at the time the order is placed.

## CONDITIONS OF SALE AND LIMITED

### PLEASE READ BEFORE ORDERING!

Clifton Seed Company warrants to the extent of the purchase price that seeds it sells are as described on the container as required by State and Federal seed laws within recognized tolerances. There is no assurance of seed or crop performance. Our liability, whether contractual or otherwise, is limited to the purchase price of the seeds. We give no other or further warranty, express or implied of merchantability, fitness for purpose or otherwise. Prices quoted for seeds are based on this limited warranty and limited liability. These warranties and limitation of liability cannot be altered or amended except by written consent signed by an authorized representative of Clifton Seed Co. Seeds not accepted under these conditions must be returned at once in original unopened containers and the purchase price will be refunded. By acceptance of seeds buyer acknowledges that the limitations and disclaimers herein described are conditions of sale and constitute the entire agreement between the buyer and Clifton Seed Co.

## MEDIATION OF DISPUTES

The laws of several states require arbitration, conciliation or mediation of disputes involving allegedly defective seed before certain legal actions may be taken against a seller. A complaint (sworn for AL, AR, CO, FL, IL, IN, MN, MS, NC, SC, TX, WA; signed only in CA, GA, ID, ND, SD) must be filed with the state's Department of Agriculture or appointed commissioner within such time as to permit an inspection of seed, crops or plants. A certified copy of the complaint must be sent to Clifton Seed Co. as provided by individual state law. Information about this requirement may be obtained from the appropriate state Department of Agriculture. For states not requiring arbitration, the standard rules of the American Arbitration Association apply for any controversy arising out of or relating to the planting or use of seed that is supplied by Clifton Seed Co.

## SHIPPING

Shipping charges are the responsibility of the purchaser. Orders will be shipped via U.P.S., motor freight or the U.S. Postal Service unless otherwise requested. Clifton Seed Co. reserves the right to ship by the best means of conveyance when necessary. Additional charges may apply to orders weighing over 25 pounds. Rush shipments may be subject to additional freight charges.
